Which data will be collected

Personal data is all data that can provide information about an identifiable natural person. We process your personal data because you are (have been) using our service or because you have furnished these data to us.

The purpose and principles on which we collect these data

We use these collected data for the following purposes:

- To send our newsletter and other publicities
- To call or e-mail you, when necessary for our service
- To inform you about (changes in) our services and products
- To assess and accept you as a customer, supplier or other third party, to conclude an agreement with you
- Concluding and performing agreements with suppliers, business partners or other third parties in relation to any agreements with you
- To develop and improve our services
- To increase the safety, security, health and integrity
- To analyze your behavior on our website, aiming to improve this website
- To provide you with the requested information and to respond to your questions
- To meet laws and regulations on which we rest

Sharing personal data with a third party

We only share your personal data with a third party, if this is necessary for the execution of our agreement and to fulfill any possible legal obligation. This can involve banks, insurance companies, ICT services, accountants, advisors, suppliers and subcontractors.

We conclude a processing agreement with the companies whom process your data in our assignment, to make sure your data will be processed with the same level of security and confidentiality. We remain responsible for this processing. If we furnish your personal data to a third party, we will only do so with your explicit consent.

Cookies

Our website uses cookies. Cookies are small text files, which will be placed inside your computer by the internet browser automatically. By using a session cookie, we can keep a record of the webpages you visit and which options you use. We use this data amongst others to make our website more user friendly. Session cookies will be deleted automatically, after closing your browser. You can adjust your internet with a warning, when a cookie will be installed. You can also block all cookies, but this will limit the possibilities of our website.

Marketing

Social Media (LinkedIn, Twitter, Facebook)

These companies place cookies which keep track of the pages you use as a visitor, so they can show you relevant adverts. We do not control any processing of this data. Security and storing period
